They have been a number of important recent initiatives which will shape the development and direction of AiBEC. The Australian and NZ Institute of Insurance and Finance (ANZIIF) has agreed to a strategic partnership with AiBEC to develop a Certificate and Advanced Certificate for Claims Consultants. This is a major achievement and the courses being developed will also draw on material from other training partners ATTAR and Pointsbuild. There will be an official launch of the ANZIIF/AiBEC Courses in Melbourne on 13 November. In the meantime AiBEC will be seeking expressions of interests from members and allied supporters who wish to be identified as supporters of the courses and who wish to assist in moderating course material. Further information will be forwarded in the near future.



AiBEC has been working with the Financial Rights Legal Centre (FRLC) to establish a pro bono offering that enables AiBEC members and allied supporters to assist vulnerable insureds. A draft Memorandum of Understanding between AiBEC and FRLC has been developed, and we expect to share full details of the program soon. This initiative reflects AiBEC's commitment to giving back to the community.

In late July the chair Deniz Bekir, Melbourne director Glenn De Costa and I had the opportunity to meet **Deputy Treasurer and Financial Services Minister Daniel Mulino** and also with a group of individual members at an informal dinner. Deniz and I held a meeting with **AFCA Code Governance Committee Chair Prue Monument** and her team. These meetings are essential opportunities to represent AiBEC's position and share insights on behalf of our members.

Board Director **Nik Housh**, with input from other directors, has developed a comprehensive submission titled: 'Expert Reports Best Practice Standards – AiBEC

Guideline for Insurers'. The Insurance Council of Australia (ICA) has acknowledged the submission and is reviewing it, with a view to further consultation with AiBEC.

Additionally, AiBEC Director **James McIntosh** has been invited by ICA to participate in discussions regarding **scopes of work** — a promising step in strengthening industry collaboration.

Meanwhile, **AFCA** has called for submissions on its **Approach to General Insurance Claims Handling**. An AiBEC Technical Committee, chaired by **Grant McIntosh of Suncorp**, is preparing a detailed response on behalf of members.

In other developments there have been two well attended recent webinars one by DINCEL Structural Walling and the other by ATTAR. We have also introduced the new membership category **Individual International Member** as we see potential for expansion of the organisation outside Australia.

As we continue to grow, we remind prospective members that **membership fees are discounted until 31 December**. If you haven't yet joined AiBEC, now is the ideal time to do so.
